## Nature of Duties

1. Will be responsible for all the Resource centre activities under the guidance of PI
2. Will prepare the study design, develop decision analytic tree and markov models, formulate the model in spread sheet/ other software, statistical analysis, report writing and dissemination of results
3. Conduction of literature review including systematic review.
4. Supervise/collect primary data collection for costing and stakeholder's interviews, statistical analysis, report writing and dissemination of results.
5. To provide support for planning, managing and implementation of various components of the HTA project.
6. Field visits to survey sites for monitoring & evaluation.
7. Any other work assigned by the PI/ Co-PI/ Superior Officer/ Director.

## NOTE:

1. Who had applied previous employment notice no.JIP/PSM/HTA Project/Rectt/2020, Dated: 10.01.2020 need not be applied again, unless qualification/experience varied from previous CV. They need to send an email with updated CV (if any) citing their willingness to appear in the interview.

3. Qualification and experience should be in relevant discipline/field and from an institute of repute. Experience should have been gained after acquiring the minimum essential qualification.
