1. Qualifications as prescribed by the UGC and adopted by the University for the post of **Associate Professor** are placed at **Annexure-A**.
2. Qualifications as prescribed by the UGC and adopted by the University for the post of **Assistant Professor** are placed at **Annexure-B**.
3. Screening and Selection Criteria for the post of **Associate Professor** is placed at **Annexure-C**.
4. Screening and Selection Criteria for the post of **Assistant Professor** is placed at **Annexure-D**.
5. Methodology for calculating Academic/Research Score for the post of **Associate Professor** as per the UGC is placed at **Annexure-E**.
6. **The candidates who had applied against the post of Associate Professor (Psychology) or Assistant Professor (Psychology) vide Advt. No. 01/2018 need to apply afresh. However, such candidates will be exempted for payment of Application processing fee against this Advertisement.**
7. The candidates are required to attach the following documentary evidence failing which the claim will not be entertained:
 - (a) As per the Public Notice No. F.1-1/2018(Journal/CARE) dated 16-09-2020 (**Annexure-F**), Research Publications only from the journals indexed in UGC-CARE List should be considered prospectively for any purpose.
 - (b) Proof of Peer-Reviewed/ UGC Listed Journals.
 - (c) Proof of Impact Factor as per Thomson Reuters List, wherever applicable.
 - (d) Proof of Research Guidance issued by competent authority of the Concerned University, wherever applicable.
8. *The candidates are advised to fill the marks secured in various examinations properly. In case of any variation in marks (filled vis-à-vis marks in original documents/ mark sheets) found at the time of document verification, the candidate may not be allowed to attend the interview.*
9. The University shall reserve the right to change the number of posts/category, not to fill any post and withdraw the advertised posts at any time without assigning any reason thereof.
10. Only those possessing prescribed qualifications may apply online up to **November 08, 2020**. **Thereafter, website link will be disabled. The candidates are strictly advised to apply online well in advance without waiting for the last date of submission of online form.** The applicants are required to submit the printed copy of online application form along with self-attested copies of relevant testimonials (from Matriculation onwards) and publications by **November 16, 2020 (upto 5.00 PM)**. The University shall not be responsible for postal delay, if any. In case, last date for submission of Print/hard copy falls on holiday, then next working day shall be treated as last date.
11. **Application Processing fee as under can be paid online (Net banking/Credit Card/Debit Card) through University website as per the above schedule:**
 - a) Male (irrespective of State) and Female (Non-Haryana resident) : **Rs. 1200/-**
 - b) Female (Haryana Resident) : **Rs. 600/-**
 - c) SC/BC/EWS (Haryana Resident) : **Rs. 300/-**
 - d) Person with Disabilities (PwD) and Ex-Servicemen (Haryana Resident) : **Exempted from Fees**
12. The above benefit of fee concession will be given only to those who are domicile of Haryana State.
13. Separate application form is required to be submitted for each post along with requisite fee.
14. The eligibility of candidates will be determined as on the last date fixed for submission of online application form.
15. Reservation will be as per the Haryana Government norms.

16. The benefit of reservation will be given only to those SC/BCA/BCB/Persons with Disabilities/ESM /EWS candidates, who are domicile of Haryana State. Such candidates are required to attach/upload relevant Certificate duly issued by the competent authority at the time of filling online application.
17. ESM/DESM candidates of Haryana claiming benefit will have to produce the valid Eligibility Certificate from the concerned Zila Sainik Board at the time of interview. Mere dependent certificate will not be entertained. ESM candidates should also produce attested photo copy of identity card issued by concerned Zila Sainik Board at the time of interview.
18. NONE OF THE PERSON BELOW SHALL FALL WITHIN DEFINITION OF WORD DEPENDENT OF EXSERVICEMEN IN TERMS OF HARYANA GOVT. LETTER NO.12/37/79-GSIII DATED 21-11-1980:-
 - a) A person working on adhoc basis against the post advertised or somewhere else.
 - b) A person unemployed at the time of making the application but he may have other source of income viz. from agriculture, trade, property, Bank balance etc.
 - c) A person who is a member of the joint Hindu family and remains dependent upon the Karta till there is partition in the family or he ceases to be a member of the joint Hindu family and is obliged to pass on all his income to the Karta and he draws money for his subsistence from the pool of the joint Hindu family with the consent of the Karta.
 - d) A candidate who is a member of the joint Hindu family is employed on ad hoc basis but he is otherwise dependent on his father.
19. Incomplete applications or the applications received without the prescribed fee or received after the last date of receipt of applications are liable to be rejected.

Note:

4% horizontal reservation of the total posts will be provided to the persons with benchmark disabilities (PwBD) belonging to Haryana State with 40% or more disability. Reservation for the persons with disabilities in Group 'A' or Group 'B' posts shall be computed on the basis of total number of vacancies occurring in direct recruitment quota in all the Group 'A' posts or Group 'B' posts respectively in the cadre.

However, if eligible persons are not found available in response to this advertisement, the posts will be filled out of general category and the points meant for persons with disabilities shall be carried forward for being filled from future vacancies.
