Initial contract period will be upto 17 September 2021, which can be extended based on periodic performance review and to be co- terminus with the Project period.

A. Key Responsibilities:

The individual consultant is required to take up comprehensive monitoring of each watershed project to evaluate the field level implementation of the watershed development activities as well as their impact on the livelihood of the beneficiaries. Key responsibilities under the project will be as under:

- a. Periodic monitoring of the projects (Technical, Physical and Financial)
- b. Identification of watersheds, desk and field appraisal of DPRs submitted by PFAs, preparation of MoS for Project Sanctioning Committee (PSC)
- c. Scrutiny of disbursement claims of PFAs and processing of release claims
- d. Conduct of meetings with PFAs and structured capacity building plan for NGO staff and village level organizations.
- e. Assisting in preparation, desk scrutiny & field appraisal of DPRs of Climate Proofing Projects
- f. Check, monitor and correct MIS entries at local level (PFA enter the data)
- g. Support in (monitoring) data consolidation at district or Regional Office level
- h. Follow up and monitoring of MIS and submission of report to Head Office
- i. Documentation of best practices
- j. Preparation/verification and submission of quarterly/half yearly progress report to Head Office.
- k. Scrutiny and verification of Project Completion Reports
- I. Web based monitoring of watershed projects through BHUVAN portal
- m. Any other work assigned by the Regional Offices

B. Eligibility Criteria (Educational Qualification, Experience, Other Knowledge / Skills):

The candidate must be a graduate in relevant stream from a recognized university with minimum 60% marks or equivalent CGPA. The candidate should have at-least 03 years of relevant work experience post completion of graduation;

ii. Graduate in any discipline with Post-Graduation/ PhD in relevant stream from a recognized university with minimum 55% marks or equivalent CGPA. The candidate should have at-least 01 year of relevant work experience post PG/PhD qualification.

Agriculture, Agricultural Engineering, Soil Science, Agronomy, Water Resource Development, Environment Science, Hydrology, Crop Science or any other related stream.

Initial 03 months shall be of probation period. In case the contract is considered for renewal, an annual rise of maximum 5% linked to performance would be considered.

Thereafter, the contract will be terminable by three months' notice period on either side as per the Company's policy.
