Applications are invited for the post of **Junior Research Fellow (JRF)** in a Ministry of Electronics and Information Technology funded research project entitled “ **Resource Constrained AI** ”.

Objective of the Project:

To develop resource constrained edge level embedded implementations of AI algorithms, in specific, deep learning algorithms for IoT applications.

Eligibility:

Essential Qualification : The candidate should have M.Tech. / M.Sc. degree in Computer Science/ Electronics with 60% of marks (CGPA of 6.5 in 10 point scale).

Desirable Qualifications: Candidate must qualify GATE/NET or similar other national level ranking.

Fellowship:

As per DST norms.

Duration:

The initial appointment will be for one year, which is extendable up to the duration of the project, solely based on performance.
