Sub: Filling up of the post of Deputy Chief Engineer (Civil) (Dy. HoD) (One Post) by absorption through composite method in Deendayal Port Trust (formerly Kandla Port Trust) – Applications called for- Reg.

Sir/Madam,

Applications are invited for filling up of the post of Deputy Chief Engineer (Civil) (Dy. HoD) (One Post) in Deendayal Port Trust, in the scale of pay of Rs.80,000 - 2,20,000 (Pre- revised Rs. 16,000-20,800), by Absorption through Composite method from the eligible and willing Officers of Major Port Trusts, fulfilling the eligibility criteria prescribed in the Recruitment Rule for the said post. The copy of the Recruitment Rule is enclosed as **Annexure – I**.

3. The eligible and willing officers, who satisfy the eligibility criteria for the post of Deputy Chief Engineer (Civil), as per **Annexure I**, have to submit their application through "Online Application Portal (OAP)" of the Ministry of Shipping website http://onlinevacancy.shipmin.nic.in followed by submission of print out of application to this port, as under:

How to apply:

- a) The applicants are requested to apply in the "Online Application Portal" of the Ministry of Shipping (http://onlinevacancy.shipmin.nic.in). The applicant has to register in the Online Application Portal. No application other than OAP shall be accepted.
- b) The candidate will submit the printout of application form to his administrative Port for onward forwarding. The Administrative Ports are required to forward the applications of the candidates along with the following documents: -
 - (i) Certified copies of APARs for the last 5 years (1.4.2014 to 31.3.2020) attested by officer not below the rank of Dy. HoD on each page;

- (ii) A statement showing year-wise availability of ACR/APARs and grading duly signed by the Dy. Chairman/Chairman as per the Ministry's letter dated 1.2.2007. If APAR for a particular year during the last 5 years is not available, "No Report Certificate" may be furnished alongwith ACR/APARs of the preceding years;
- (iii) Attested photocopies of all certificates and proof of educational qualification, present and past work experience in the respective post and pay scale;
- (iv) No objection certificate from the respective Port (Annexure- II)
- (v) Undertaking of the applicant to the effect that the candidature will not be withdrawn, if selected by Services Selection Committee;
- (vi) Vigilance and administrative clearance of the concerned Port, as per enclosed pro forma (**Annexure III**) and
- (vii) Two passport size photographs.

- 4. The crucial date for determining eligibility of the applicants will be 1st January, 2021.
- 5. If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty along with necessary documents may be sent by the forwarding authority along with the application. Vigilance report is to be furnished in the format prescribed, vide Ministry of Shipping's letter No. A12022/ 10/2005-PE.I dated 27.8.2010, copy of which is attached as **Annexure III.**
- 6. The Port Officials who withdraws his candidature for the post after his selection by the Service Selection Committee, will be liable for debarment from future selection to DyHoD level posts in this port, for a period of two years.

7. The applications received through proper channel will only be entertained. The applications received after the last date or without APARs/ACRs/ enclosures or otherwise incomplete will not be considered.
