ODISHA TEACHER ELIGIBILITY TEST (OTET), 2021 (1ST)

Applications are invited from eligible candidates for appearing at the Odisha Teacher Eligibility Test (OTET), 2021 (1st) as per the following guidelines :-

1. Applications shall be received through ONLINE mode only on visiting the website "www.bseodisha.ac.in".
2. ONLINE link will be available (24 x 7) for Paper-I & II separately from 20/02/2021 08 am to 08/03/2021, 11.45 pm.
3. The payment of fee shall be done through Axis Bank Easy Pay either in online or offline mode latest by 11.45 pm of 08/03/2021. However submission of form through online can be carried out till 09/03/2021 midnight.
4. The step by step instructions for online registration, applicability & eligibility of candidates, syllabus & its structure, instructions for physically handicapped candidates & format for continuing certificate are available in the website "www.bseodisha.ac.in".
5. Candidates can appear Paper-I or Paper-II or both the papers as per their eligibility. The candidates appearing both Paper-I & II shall have to fill up application form separately.
6. Under no circumstances the last date for submission of application forms shall be extended.
7. In case the information furnished by the candidate is found to be false/ fake, the candidature/ result of the candidate shall be cancelled and he/ she shall be liable for prosecution as per the rule.
8. The informations once submitted by the candidate relating to personal data, address, caste, subject etc. during online registration can not be changed at any later stage.
